Money goes to the APP Fund (Permanent Preservation Area) and will transform the families that live there, The Bioma Park, agro education area, courses, health, protection, emergency communication, seedling house and social meeting point, creating a community smart to protect this area of permanent preservation.

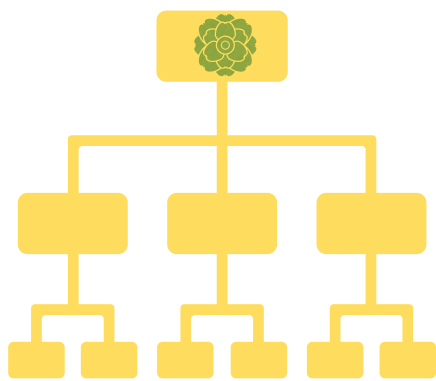
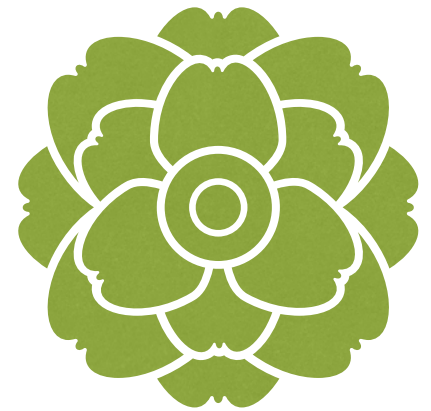

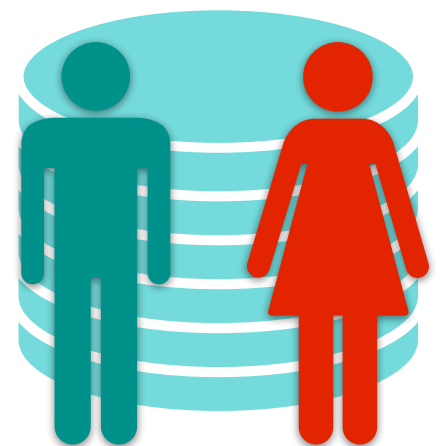
Bioma Park are carefully geolocated permanent preservation areas.

Bioma Smart Community - Concept

Every Bioma Park is associated with creating sustainable ways to conserve the area's green assets. In order to carry out a development plan that will be active for the next two hundred years or more, the community and family associations will be structured with technological solutions that implement ISO 37120 (International Standard Organization - Sustainable development of communities) standards. The goal is for every Bioma Park to become a Smart Bioma Community.

Bioma Smart Community - Automation

Every sustainable community needs technologies and automations that transform the community as a whole, some implementation concepts are, monitoring of the area around the Bioma Park done by drone automation every 4 hours, Smart servers for the community with courses in agro and agro technology, agroindustrial machines with infrared technology to dehydrate perishables for export, transport drone to deliver to the warehouse in the Capital, strategic solar panels and support tablets with integration to the BioTrace App for planting management and monitoring of bio products.

Bioma Smart Community - Education

The server installed for the community serves for professional qualification whose objective is to instruct people who have or do not have some type of education, some or no technical instruction, for insertion in the labor market and that generates a community capable of overcoming its challenges. In addition, videos of agrarian education courses and also courses in basic school subjects, art and culture courses, these mini servers transmit via Wi-Fi and everyone can follow it from their support device.

Bioma Smart Community - Governance

Every SBC (Smart Bioma Community) is governed by associations made by the families who live near these conservation areas and to generate governance within the family and with the Bioma Park program we use the Governance system attributed to the third sector. Each association having members, president, secretary, treasurer, alternate.

Bioma Smart Community - Security

To monitor the conservation, preservation and family area, every BSC will have its own community analysis drone, automated to analyze the land every morning and also create foliage growth data. These data are important to understand the areas inside and outside the community and improve the safety of these families.

Bioma Smart Community - Health

The distance from the capital's communities demonstrate the need to create and educate communities with medical, biomedical and psychological knowledge, the forestry analysis pad will also have a medical application to help solve the health problems of families in the community, in addition to informing the Forest remedies in place that can help cure these diseases.

Bioma Smart Community - Energy

To keep the production of products stable we need a power station capable of keeping the server and machines running daily, this energy is also essential to charge the pads and drones to continue generating Open Data about communities and their human development.

Bioma Smart Community - Open Data

All data about the community are open to the government, entities, institutions, among others, to better promote the transformation of the Amazonian people.

Bioma Smart Community - Tourism

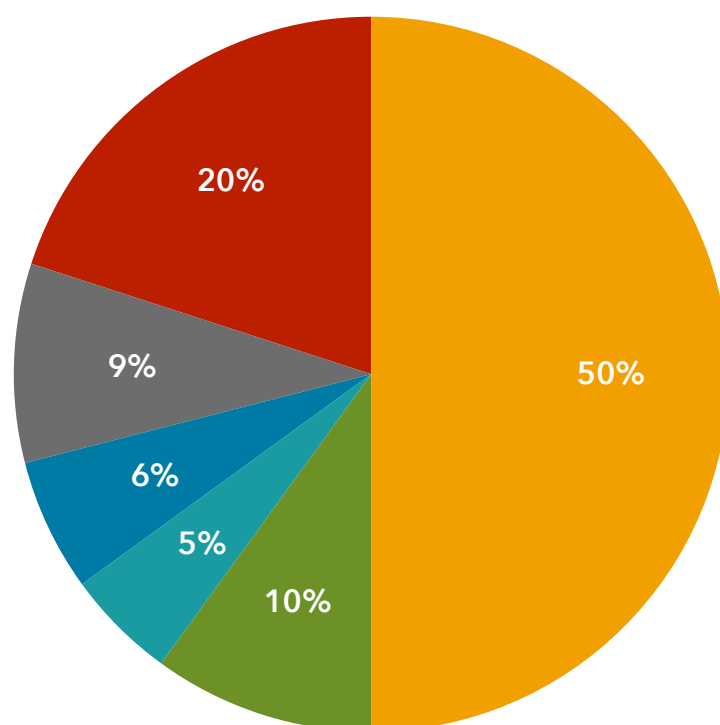


Bioma Park tokens

Thera Amazon will issue 50 different types of Bioma tokens, all with different acronyms, names and presentations, when the maximum limit is reached in the Bioma Smart Contract, they will have been minted a total of fifty tokens for each protective park of tokens, called (BIOMA), These tokens create a new blockchain-based ecosystem for Earth conservation and preservation. These tokens will be offered on multiple platforms to allow participants to purchase tokens in different ways, as well as contribute to and support the development of Thera Amazon. Starting in the first quarter of 2023, participants will have the ability to contribute and receive Bioma Tokens in exchange for sending their crypto. Of all tokens, 80% will be offered in multiple sales. 20% will be retained by the company, staff, advisors, founders and future employees.

Funds Distribution:

To develop its strategy, expand its service, and manage its day-to-day schedule, Thera Amazon incurs expenses related to Sales, General Operations, Marketing and Administration, Corporate Tax, Rebranding and Land Acquisition, Drone Maintenance, Police, Land analysis, team payments, forest surveillance, etc ... The funds raised during the activities will be fully and completely used for the development of the platform and the smart city, as well as its associated applications and costs of its collaborators. Depending on the volume of funds raised, a specific scheme will be chosen for allocating the fund. At the beginning, 4 important tasks need to be solved. The first is to expand the team, as well as recruit experts and qualified collaborators and prepare a transparent structure and business activity plan for each smart city. The second must be listed on token exchange platforms. The third is effective marketing strategy development and execution. The fourth is to develop strategic partnerships that will allow the smart city to expand its reach by distributing more sustainable products from the Amazon to other places, as well as promote the Thera economy in the Amazon region to change the status quo of people and companies.

Platform Development

15% will be used for core development, adoption of Blockchain technologies and smart contracts, creation of new products and services. Furthermore, it describes the software technology and blockchain implementation for the project suites.

Infrastructure Development

30% of the funds will go towards infrastructure development. This includes towers, drones, and physical equipment and hardware to configure our platforms. Solar panels, machines, batteries, off-grid power generators, internet services

Marketing

15% of the total funds raised will be used to cover expenses for promoting the project and expanding the user base, promotion in new markets, international partnerships, visits to conferences and related exhibitions.

Operations

15% will be used for payment of services, accounting, operating expenses and others.

Partnerships

8% of the funds raised will be directed towards strategic partnerships and the growth of our networks. This will include acquisition and hiring costs or certain key human resources.

Product Distribution

7% of the funds will be used for the Channel's strategic product development efforts. This includes future partnerships and product distribution. In many cases, it will be more efficient to make more stock of certain products in the future, as for initial development we will focus on weekly and monthly products.

Legal

5% of the cost will go towards legal expenses, development costs and installing satellite offices in certain regions.

Reserve

5% will be kept in reserve for unexpected expenses.

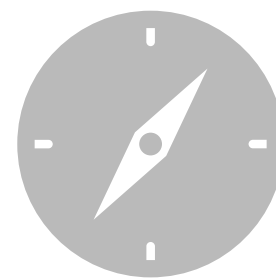
